
Idaho Chapter Officer Changes-ChuckRaddon

Recently there have been changes in the Officers and Board members of the Idaho Chapter. In late February, Chuck Raddon felt it necessary to resign as Chapter President. Chuck feels strongly that after serving 9 years it is time for new chapter leadership. Chuck will continue to serve on the Idaho Chapter Board as "Past President" and as chair of the annual Lolo Work parties. Rather than conduct a week long work party, there will be 3 separate events conducting minor trail work, surveying the work that needs to be completed next year and a complete tour of the Lolo Motorway to plan for future events at each end of the trail.

The leadership issue and chapter direction been discussed at length in emails between the Chapter Board members and was discussed at the Chapter meeting on April 9 at Spalding. At that meeting Laurie Brown of Oakesdale, was added to the board. The need to have more meetings and events in southern Idaho was a topic as was the need to be more insistence on dues paying by members. Since the bylaws call for election of officers in odd numbered years, the default decision by the end of the meeting was to get through this year and try and develop new leadership and chapter focus by next spring in time for spring 2017 elections. Pat Rathmann is working with the Secretary of State's office to get the Chapter reinstated as a nonprofit corporation in Idaho. Steve Lee has submitted paperwork to the IRS to reinstate the Chapter's tax exempt status. Rathmann is also serving as the chapter representative to the Idaho Governor's Lewis and Clark Trail Committee, which among other duties distributes the money collected for the Idaho L&C License Plates. That is enough duties to provide a full plate for the Vice President. Perhaps we need a southern Idaho VP to focus on meetings and events in the southern part of the state. If you have thoughts or ideas please discuss them with one of the Board members.

Lolo Work Week needs Volunteers

WHAT: The Lolo Trail, that route over the Bitterroot Mountains traveled by Lewis and Clark and many other explorers and travelers needs help. Spend 5 days/ 6 nights helping maintain the trail, interpretive signs, and related historic sites. We will set up a camp near Sprit Revival Ridge and spend our days working on a variety of projects, doing a little sightseeing and learning a little history.

WHEN: move in on Sunday, July 31st work the following week and come out of the mountains Saturday, August 6th.

We'll send you a detailed fourpage information packet about the project and what to expect before you commit to joining us.

WHAT YOU WILL GAIN: The satisfaction of doing work that needs to be done, visits to many historic sites, some "oh-Wows" at the views of the endless mountains surrounding you, an idea of how the Nez Perce used these mountains, an understanding of the challenge of modern management of a historic resource, a whole lot of local history, lots of Lewis and Clark history, new friends, some sore muscles and perhaps a few blisters.

THE COST: Your week will cost you \$50 plus your travel costs. We'll do our own cooking. We've received a grant to help with rest of the costs.

WHAT ELSE IS NEEDED? Bring a tent, mattress pad and sleeping bag for the often cool nights and hard ground. No pickup-campers or travel trailers as the road is very primitive and you would experience significant damage. We suggest you drive SUVs or empty pickups with heavy duty tires because tire side wall damage is common. To travel to the work sites from camp we will consolidate crews into as few vehicles as possible. In regard to clothing think layers. Mountain weather is extremely variable that time of year and a bright sunshiny morning with "T" shirt temperatures often leads to an afternoon thunderstorm with heavy rain and hail. Be prepared.

The work project is organized by the Idaho Chapter of the Lewis and Clark Trail Heritage Foundation.

Idaho Governor's Lewis and Clark Trail Committee Report

On Tuesday, April 5, Chairman Bob Russell, convened the meeting of the Idaho Governor's Lewis and Clark Trail Committee in Boise. Our Business Meeting was held from 9 am to 5 pm at The Cottage at the Idaho Botanical Gardens.

After the meeting was called to order, Jim Fazio shared an historical moment from the Lewis and Clark Journals. Steve Lucas, Clearwater Nez Perce Archaeologist distributed maps and other information from Steve Russell's research on up-dating the trail route. Members were asked to submit comments to Steve Lucas on both the maps he shared and his report: Lolo Trail National Historic Landmark.

Andy Hawes from the Western Pacific Timber Company reported on the potential logging plans on 13 Mile Camp and the stalled Lochsa Land Exchange. He suggested that the Committee draft a letter to both Senator Risch and the Forrest Service in order to promote delay on any logging plans. There is money in the Land and Conservation Fund to purchase that parcel, but WPT feels that an agreement would delay a Land Exchange even further. Bob Russell will draft another letter in behalf of the Governor's Committee. Dax Chizum from the Idaho Historical Society was introduced and gave a financial report. There was no change from past years. Jan Gallimore congratulated the Committee on the excellent report that the Committee had presented to the Governor's Office and the IHS several years ago. She suggested that the Committee prepare an up-dated report detailing all the Committee's accomplishments. Additional reports were made concerning participation in the Idaho Historical Day, the Sacajawea Center Signage (no progress), and no additional information on the National Forest Management plans or the Nez Perce Clearwater MOU. Pat Rathmann submitted the Idaho Chapter Report. The Committee agreed to invite Allen Pinkham from the Nez Perce Tribe to join the Committee.

The next meeting will be held in Lewiston on October 13, 14 and 15. Pat Rathmann and Anne Shorzman will facilitate the plans.

Field Trips on Wednesday started with a tour of the new downtown JUMP Center and continued in the afternoon with a tour of two Oregon Trail sites led by retired Idaho Historian Larry Jones after which the meeting was adjourned.

2016 Fall Regional Meeting Twin Cities of Minnesota.

Minneapolis-St. Paul Regional Meeting Set for September 17 to 19, 2016.
