Even after more than 200 years, previously unknown information about Lewis and Clark is still being discovered. Just such a discovery is a letter written by Meriwether Lewis to William Linnard in Philadelphia on June 6, 1803. This letter serves to give more information regarding the preparation phase of the Lewis and Clark Corps of

receive a transcript of each letter mentioned in the program.

Since 2003
Hainesworth has been intensively studying the Expedition and has become increasingly involved in researching primary sources to discover heretofore-unknown aspects of the Lewis and Clark

Expedition.

This program is being sponsored by the Washington State Chapter of the Lewis and Clark Trail Heritage Foundation www.lewisandclark.org. It is free with regular Fort Nisqually admission. Located in Tacoma's Point Defiance Park, Fort Nisqually Living History Museum is a restoration

of the Hudson's Bay Company outpost on the Puget Sound where visitors can journey back in time to the midnineteenth century. The site includes a Visitor Center and Museum Store. Fort admission is: Adults - \$6; Senior/ Active Military/Student -\$5; Youth (13-17) \$4; Child (4-12) \$3.

The Washington State Chapter Annual Meeting was held February 6 2010 at the Washington State History Museum in Tacoma, with about 40 people in attendance.

President Jill Stephenson started the meeting at 10:15 AM with the announcement that Tim Underwood will turn over the newsletter Worthy of Notice (WON) to new coeditors John Orthmann and Layne Corneliuson.

Robert Heacock and John also described the process by which two bicentennial dugout canoes were donated to Sacajawea State Park by the Chapter, one canoe by the Chapter and one by John and Layne.

Linda Underwood will proceed with securing Chapter name tags for around \$10 and many signed up at the meeting.

Rob also encouraged everyone to get their email address to him, as we do intend to use email to supplement our WON newsletter

Barb Kubik reminded us of the Foundation Annual Meeting to be held in Lewiston Idaho this August 1-4 and that registration info should be in the mail this week. Wendy Raney provided us with a new book 'Across the Endless River' by Thad Carhart (Doubleday), an account of Jean-Baptiste Charbonneau's time in Europe. The book was auctioned off in a silent auction to Doc Wesselius.

Mention was also made of the cooperative agreement between the Foundation and the Boy Scouts of America, and that will enhance our ability to with them.

Barb also announced that the Governors Lewis and Clark Committee will be meeting at 1:30 PM today.

It was also announce that long time member Ralph Rudeen has died and that his wife Jackie will be having her birthday tomorrow and a birthday card was circulated.

Larry mentioned that February 20 at Lewis and Clark College in Portland will be a program featuring Dr Gary Moulton, Dr Steven Beckham and Roger Wendlick For more information see the Oregon Chapter website.

He also mentioned that Lorna Hainsworth who recently published an article on a lost letter by Captain Lewis is available in late March for presentations. Larry also encouraged all members to assist where they can and to help at the Annual Meeting in Lewiston.

He also mentioned that Dr. Stephen Forrest is the new Director of Operations and Membership Services of the National LCTHF Foundation.

Chapter elections were held and all positions were renewed by acclimation.

We were then privileged to hear from John Jackson who explained the research that has gone into his latest book about Captain Lewis. He also read portions of the text and answered questions, and we had a subsequent discussion of Captain Lewis.

Canoe for Sacajawea State Park

The Washington State Chapter of The Lewis and Clark Trail Heritage Foundation, Inc has purchased a bicentennial dugout canoe, with the purpose of donating the canoe to the Sacajawea State Park and Interpretive Center in Pasco Washington.

The canoe is a ponderosa pine from the Clearwater River drainage in Idaho. It was originally obtained the Hog Heaven Muzzle Loaders (HHML) in Orofino from Guy Bennett Lumber, in the spring 2005. This hull was roughed out that spring by the Club members and then finished by Vern Illi.

It first entered the Clearwater River on October 6, 2005 one mile below Canoe Camp, and then proceeded down the Clearwater River arriving in Lewiston 2 days later, manned by HHML and also Discovery Expedition of St. Charles (DESC) members.

After traveling down the Snake River, it arrived at Sacajawea State Park on October 16, 2005 and then with a DESC crew proceeded down the Columbia River to Chinook County Park, near the mouth of the Columbia River.

After wintering back in Idaho, the canoe was taken in July 2006 to the Yellowstone River in Montana and rafted with another canoe for the return trip down the Missouri River to St Louis.

The canoe will be on display the Sacajawea State Park in a permanent exhibit

Grandson of Sgt Gass buried in Spokane

A good example of the need to keep subscribing to a real periodical for leisurely reading. Online content is fine for bank statements, but you just never know what you will find when you are sitting comfortably on the couch.

Such was circumstance when I came across an article under the 'Landmarks' section of the July 23, 2009 Spokesman Review. Written by Stefanie Pettit, it describes how a grandson of Sgt Patrick Gass came to live his final years in Spokane. The grandson, Benjamin Patrick Brierley died on January 4, 1935 at age 57 of alcoholism in the Pennington Hotel, what is now the east wing of the famous Davenport Hotel. His headstone is in-

scribed 'GRANDSON OF SERGT GASS OF L&C EX-PEDITION'. There is not much information available about Brierley, but he was born February 3, 1877 in Wilmington, Delaware, and apparently traveled the country as a representative of a photography company.

His grave is in Greenwood Memorial Terrace at 211 North Government Way in Spokane. It is in lawn #26 in the natural setting of the 'nonendowed care section' (meaning unlandscaped) and is adjacent the paved driveway.
